1. PURPOSE OF THE PROCESSING OPERATION

ECDC processes the personal data collected in accordance with Regulation (EU) 2018/1725. The purpose of the processing is the following:

The ESCAIDE Funding initiative provides a funding opportunity for early career researchers who will be presenting abstracts at ESCAIDE. As part of the selection process, abstract presenters who have applied to the initiative will be asked to provide additional information to assess their suitability based on the eligibility and preference criteria. From this pool of applicants, a portion will be selected for participation, taking into account a set of criteria and budget availability. Those who are chosen will receive an invitation from the ECDC, encompassing coverage of expenses. This includes complimentary conference registration, travel expenses, accommodation, and daily allowances, all in accordance with the guidelines stipulated in the ECDC Rules on Reimbursements.

6. HOW LONG DO WE KEEP YOUR DATA?

The data for successful applicants will be retained for a maximum of 7 years.

7. HOW DO WE PROTECT AND SAFEGUARD YOUR INFORMATION?

In order to protect your personal data, a number of technical and organisational measures have been put in place. Technical measures include appropriate actions to address online security, risk of data loss, alteration of data or unauthorised access, taking into consideration the risk presented by the processing and the nature of the data being processed. Organisational measures include restricting access to the data to authorised persons with a legitimate need to know for the purposes of this processing operation.

8. WHAT ARE YOUR RIGHTS AND HOW YOU CAN EXERCISE THEM?
